# Creating the organizational climate with a higher awareness of the proper execution of research funds

The University has begun to take steps forward becoming a "social prototyping research university" to create new values for social symbiosis. To this end, we must promote research and open innovation more than ever. However, no matter how advanced our research is in progress, acting against research ethics in the process is not acceptable. Under the Ritsumeikan University Research Ethics Guidelines, the University has established the responsibilities and the code of conduct for researchers, and has been striving to ensure more proper execution of research funds.

In February 2021, Ministry of Education, Culture, Sport, Science and Technology (MEXT) revised the "Guidelines for Management and Audit of Public Research Funds at Research Institutions (Implementation Standards)", and requires universities to implement thorough measures to



prevent improper use, setting three pillars of "strengthening governance", "raising awareness", and "strengthening systems to prevent misconduct".

As Chief Management Director, I will work on compliance education and edificatory activities in order to create the organizational climate with high awareness for preventing improper use of research funds. As part of the activities, we will publish "Guidepost—Newsletter for Proper Execution of Public Research Funds" to provide information on the proper execution of public research funds on a regular basis.

We hope that you will refer to the information in this newsletter, deepen the knowledge on the proper execution of public research funds, and carry out your daily research activities properly without any troubles.

# Points to note in the revision of "Guidelines of Management and Audit of Public Research Funds"

In the management and audit system based on the guidelines, each research institution has established a basic system and has been taking measures to prevent misconduct, but various forms of fraudulent research expenses are still occurring at other universities and research institutions. In response to this situation, MEXT has set the following three items as the pillars for strengthening prevention of misconduct in order to raise awareness of research institutions as a whole and create the organizational climates with a high level of awareness regarding the prevention of research misconduct.

Especially, MEXT requests research institutions to newly implement "edificatory activities" in addition to the current "compliance education" and "submitting a pledge".



# Three Pillars to Strengthen Preventive Measures in the Revised Guidelines

### Strengthen Governance

Clarifying the leadership and role of Chief Management Officer to

- ·Expressing a strong commitment to eradicating misconduct by Chief Management Officer and deliberating at board meetings are to be required.
- ·As part of the role of auditors, checking and making comments on the status of the internal control over prevention of misconduct from the perspective of the entire institution is to be required.
- ·Thoroughly implement the PDCA cycle to prevent misconduct to carry out effective internal control

Le.g. reflection of the internal auditing results on the plan to prevent misconduct)

### Raising Awareness

Promoting the sense of prevention of misconduct among all the member of education and edificatory activities

- · As a measure taken by Overall Management Officer, laying out comprehensive approach to foster the organizational climate that prevents misconduct is to be required
- ·Continuous implementation of edificatory activities to eradicate misconduct (raising awareness of it and making it sink in) is to be required.
- ·Edificatory activities are conducted in conjunction with and complementary to compliance education, and include referring to the internal auditing results to share an understanding.

### Strengthening Systems to Prevent Misconduct

Strengthening the audit function and eliminating "opportunities" of

- · Participation of those equipped with specialized knowledge (Certified Public Accountants) in the internal audit is to be required
- ·Strengthening cooperation among auditors, accounting auditors, and internal audit division to enhance the checking function of the fraud prevention system.
- ·Introducing an expenditure system that does not allow researchers to involve in payment, such as not letting researchers use cooperate cards.

# To promote the proper use of research fund

The rules regarding public research funds are changing every year. When you spend research funds, we would request your efforts to execute it properly by making use of "Guidelines for Disbursement of Research Funds". # (For faculties and researchers who are going to apply for or receive public research funds in this fiscal year



To apply for or receive public research funds, it is required to attend compliance education and submit a "pledge". Last year, we made a university-wide effort to have those who had taken the course or submitted the pledge before FY 2019 retake and resubmit. As a result, all the recipients of public research funds in FY 2021 have been confirmed to have retaken and resubmitted.

In the future, when you newly apply for a public research grant, we will confirm the resubmitting status, and if it has not been submitted, we will inform you to resubmit it.
